UE/679/2016, legislative Decree n.196/2003 (legislative Decree n.101 del 10-08-2018) release this Brief Privacy Policy to complement the extended one, published and available on the website of the Netcomm Forum Event.

Processed Data: Data processing concerns the data acquired with this disclaimer, the registration form and Your image acquired through Footage according to the above terms.
